- 3. Enroll and Pay:** After registering, simply click on the Course Catalogue link from the top toolbar and click ENROLL NOW. If you have a PayPal account, simply login with your credentials. If you do not, click the "Create Account" button. Provide your credit card payment information and click "Create Account & Pay Now" button.
